UP / UPC – Main considerations

Current situation

Only a **centralized European patent granting procedure** (before the EPO)

Leads to a bundle of national patents after the validation procedure

New opportunities... and risks

- > 1 translation (for UP),
- 1 renewal (with the EPO),
- 1 specialized court rendering quick decision,
- 1 decision for enforcement in 17 countries,
- low cost for a patent covering 17 countries
 BUT
- risk of central revocation
- uncertainty about UPC case law
- costly if usually validate in 4 or less UPC countries
- some key countries not covered by UP
- not possible to let lapse some countries and to renew some others

Unitary Patent

A patent covering simultaneously all UPC Member States

> no need for a validation procedure

A pan-European patent enforced in several EU member states at once

Unitary Patent *≠* **Unified Patent Court**

- The Unitary Patent (UP) is <u>an IP right</u>, a patent, an object of property
- The Unified Patent Court (UPC) is a <u>patent court</u> with the power to issue decisions on infringement (including preliminary injunctions) and validity of both:
 - "classical" EP validated rights
 - the new Unitary Patent rights (exclusive jurisdiction)

UPC's competence is not limited to the UP!








Unitary Patent System and UPC the available options



UP / UPC Legal Framework





2 transitional measures as of Jan. 1

- Delay of the grant
- Early request for UP

Opt-out possible **Transitional period (7Y+7Y)**

 UPC and national court have shared jurisdiction for classical EP patents

Opt out from the UPC







The safest is to opt-out

It is an administrative procedure to **remove a given EP family from the jurisdiction of the UPC**.

What can be opted out?

- Any published European patent application
- Any granted European patent

Avoid the risk of a central revocation
(rather than several national actions
before each relevant national court).
Possibility to "opt back in" once

during the Sunrise period (avoid any action to be placed before the UPC).

However, opt-outs will be possible during the whole transitional period (7 to 14 years).

The opt-out is filed once for the whole EP family. No official fee is charged.

TIMELINE: Pre-Sunrise Period i.e., from Now to March 1, 2023

Data Ownership Audit

Only the owner of a European patent (EP) or supplementary protection certificate (SPC), or their representative, can validly file an opt-out request.

Our Recordals department

will check the owners of the patents listed on the European or national registers against your own data.

If necessary, this can be followed by an update of the patent register(s) via a Recordal project.

Strategic consultancy

- o loss of strategic assets through central revocation
- o unnecessary expenses
- o loss of competitiveness, etc.



Request early unitary effect

Ensure that the unitary effect of your EP shall be required before the UPC starts


